

Dear Senator Hardeman:

The 47th Legislature created the Texas Centennial of Statehood Commission and Governor Stevenson appointed me its Chairman -- its objective being to develop a program for recognizing Texas! 100th anniversary as a State. We immediately decided against any memorials, monuments, or fairs. We did decide to sponsor local historical celebrations and a full report on this phase of the program has been made to you recently.

In addition, we also decided to develop a program designed to revitalize rural life in Texas. Your chairman called together the best available technical, scientific and academic minds in our State and for more than two years we labored to develop a program which we believed would help make Texas a better place in which to live for the next 100 years. A great many Texans, both members of our Commission and private citizens, devoted a great deal of their time and energies to this program. The expense of the project, which has amounted to over \$20,000.00, has been bourne wholly by Interstate Theatres.

Finally, on February 11, 1947, I made our Commission's formal report and recommendations to the 50th Legislature, to the Governor, to the Lt. Governor and to the Speaker of the House. The report, which was printed, was presented to each member of the Legislature, and a second copy is enclosed herewith for your convenience.

I, therefore, respectfully submit that your Chairman and our Board of Directors of the Texas Centennial of State-hood Commission have discharged their responsibility fully. The next move is up to the Legislature.
