

Resigned from bank to go to Dallas, where parents had moved. During this time I studied nights, taking course in Banking, offered by American Banking Ass'n. This course was finished in Dallas, after I had entered services of Republic National Bank. Republic National Bank, Dallas, savings teller- from March 1922 to Nov. 1922, from which I resigned to accept position as Executive Secretary of the University Club of Dallas, for the promotion of a new club atop the Santa Fe Bldg. This job took 3 years. Fifteen months before the contract was let, I was offered the job of Treasurer and Auditor for Hagenbeck-Wallace Circus, owned by American Circus Corp. This company held the offer open for me for this fifteen months, until such time as I could leave the Club, Thhad promised the Club that I would not leave until

contracts were let for the new building. After letting of the contracts, and after the firm of accountants had audited my books and had given me a "Clear Bill of Health", they accepted my resignation and my employment with the Circus owners began. I remained with the Circus from Sept. 1925 until Nov. 1926, during which time Icompiled "Road Season" Reports for Hagenbeck Wallace Circus, taking care of winter-quarters books of hoth the Hagenbeck Wallace and Sells Floto Circuses during winter months. I installed the "Winter-Quarters" system for the circus, which was a sizeable task, in view of the extensive building of equipment during the winter months. I was allowed to go home in the winter months of 1926 and upon returning to Dallas was employed by General Motors Acceptance Corp. on a temporary basis, it having been my intention to return to the Circus in the Spring, accepting the position of Asst. Manager which had been offered me. My work with General Motors appeared to be more worth-while in the long run and the temporary job turned out to be a job which lasted more than 5 years. I was released by General Motors on Jan. 1,1932, reason having been given me that their "Depression" policy was tofinally reach me, which had previously reached 80 or more of my fellow workers. Instead of attempting to secure another job, I made one for myself, became engaged in manufacture, sale and operation of "Kiddy" riding devices, usually seen in parks, play-grounds and fair grounds. My interests along this line followed for the years 1932-37. My next job was with First Bancredit Corp. as credit man, which lasted for four months, until FHA withdrew appliance financing coverage and caused elimination of my department. On the day I left First Bancredit, my employment as traveling auditor for Bankers Commercial Corp., Chicago, began. Before accepting this employment, I had made some tentative arrangements that involved placing of some of my riding devices in Centennial grounds at Dallas. Shortly after taking the job with Bankers Commercial, my contracts were accepted and since I to uld not hold down both jobs, I relinquished my employment with the Finance Co., a mistake in judgement I will long regret. During following years I owned two restaurants, one at Dallas, theother at Port Arthur. I accepted a job with J. E. Presley Auto and Finance Co., Dallas, work was not pleasant due to managements treatment of people that owed him money. I resigned

to accept management Credits & Collections Buick agency, Big Spring, but the size of the Business did not justify maintaining this department.

My last job was at Camp Wallace. I was advanced from Pay-Roll Auditor to Overtime-Rate Clerk and from this position to Asst. Paymaster, from which I resigned of my own volition March 21,1941.
