#### IN CONVENTION OF THE PEOPLE OF THE RE-PUBLIC OF TEXAS JULY 4. 1845.

#### AN ORDINANCE.

Preamble reciting the official action of the Congress and President of the United States and of the President and Congress of Texas, in regard to annexation.

Whereas the Congress of the United States of America has passed resolutions providing for the annexation of Texas to that Union, which resolutions were anproved by the President of the United States on the first day of March one thousand eight hundred and forty-five: and whereas the President of the United States has submitted to Texas the first and second sections of the said resolution, as the basis upon which Texas may be admitted as one of the States of the said Union; and whereas the existing government of the Republic of Texas has assented to the proposals thus made, the terms and conditions of which are as follows.

#### JOINT RESOLUTION FOR ANNEXING TEXAS TO THE UNITED STATES.

Resolved, by the Senate and House of Representatives of the United States of America in Congress assembled. That Congress doth consent, that the territory, properly included within, and rightfully belonging to tion as a State. the Republic of Texas, may be erected into a new State, to be called the State of Texas, with a republican form of government, to be adopted by the people of said Republic, by deputies in convention assembled, with the consent of the existing government, in order that the same may be admitted as one of the States of this Union.

2nd. And be it further resolved. That the foregoing consent of Congress is given upon the following conditions, and with the following guarantees, to wit: First, Said State to be formed, subject to the U. States, the adjustment by this government, of all questions of boundary that may arise with other governments;

States harbors, navy and navy yards, docks, magazines, arms and armaments, and all other property and means pertaining to the public defence belonging to the said Republic of Texas, shall retain all the public funds, debts, What to be retained. taxes, and dues of every kind, which may belong to or be due & owing to the said Republic; and shall also retain all the vacant and unappropriated lands lying within its limits, to be applied to the payment of the debts and liabilities of said Republic of Texas, and the residue of said lands, after discharging said debts and liabilities, to be disposed of as said State may direct; but in no event are said debts and liabilities to become a Public debt of charge upon the government of the United States. Texas. Third, New States of convenient size, not exceeding New States four in number, in addition to said State of Texas, and out of Texian having sufficient population, may hereafter, by the con-territory. sent of said State, be formed out of the territory thereof. which shall be entitled to admission under the provisions of the Federal Constitution. And such states as may be formed out of that portion of said territory lving south of thirty-six degrees thirty minutes north latitude, commonly known as the Missouri Compromise Missouri Com-Line, shall be admitted into the Union, with or without established. slavery, as the people of each State, asking admission may desire. And in such State or States, as shall be formed out of said territory; north of said Missouri Compromise Line, slavery or involuntary servitude (except for crime) shall be prohibited.

Now, in order to manifest the assent of the people of this Republic as required in the above recited portions of the said resolutions; We the deputies

of the people of Texas in convention assembled in their name and by their authority, do ordain and declare, that we assent to, and accept the proposals, conditions and guarantees contained in the first and second sections of the resolution of the Congress of the United States aforesaid.

#### AN ACT,

#### To define the Boundaries of the Republic of Texas.

SEC. 1. Be it enacted by the senate and house of representatives of the republic of Texas, in congress assembled, That from and after the passage of this act, the civil and political jurisdiction of this republic be, and is hereby declared to extend to the following boundaries, to wit: beginning at the mouth of the Sabine river, and running west along the Gulf of Mexico three leagues from land, to the mouth of the Rio Grande, thence up the principal stream of said river to its source, thence due north to the forty-second degree of north latitude, thence along the

boundary line as defined in the treaty between the United States and Spain, to the beginning: and that the president be, and is hereby authorized and required to open a negotiation with the government of the United States of America, so soon as in his opinion the public interest requires it, to ascertain and define the boundary line as agreed upon in said treaty.
