

In connection with the proxy statement of American Airlines, Inc., to be forwarded to stockholders, I have answered the questions set forth below and am sending you the information expressly for use in such proxy statement.

The question numbers referred to are taken from Item 5 of Schedule 14-A of Regulation X-14 of the Securities and Exchange Commission Rules relating to the solicitation of proxies.
