CONDITIONS AND EXCEPTIONS UNDER WHICH THIS TICKET IS ISSUED.

The Conditions, Exceptions and Regulations under which this Parcel Ticket only is granted and agreed to by the Sender of the Packages on behalf of himself and Consignee are that neither the Company nor their Sub-Contractors shall be answerable in case of any loss, nor for any abstraction, nor for any loss or damage on land or at sea, to any amount beyond that of the liability of the Steamship or Railway Company by which the goods are conveyed. Packages on which no value is declared or insurance effected are forwarded entirely at the risk of Sender and Consignee, who thereby take all risks of conveyance on themselves, and also any loss arising from bad or insufficient packing, incorrect, imperfect, or illegible marks, numbers, or addresses, and any damage caused by fire at sea or on shore, breakage, leakage, evaporation, rot, rust, vermin, machinery, boilers, steam, collision, or any other accident or cause whatever.

It is stipulated that the Company accept no liability whatever for indirect claims for delays or losses of sample packages.

Articles of Glass, or contained in Glass, or of a fragile nature, are received only at Sender's Risk. The Company and their Sub-Contractors shall be exempt from all liability in regard to the condition in which Plants and other Perishable Articles may be found on arrival, from whatever cause it may arise.
