リレ-3 Keiired From Service In Ceremony

Flagship Fort Worth, a gleaming silver DC-3, joined the American Airlines mothball fleet at 9:37 p.m. Thursday.

The airlines' last DC-3, parked nose-to-nose with a lower-slung, bigger twin-engined Convair, was taken from service formally in a ceremony at Municipal Airport.

"It's a victim of service only," M. D. Miller, regional vice president in charge of sales, emphasized.

"It's only fitting that this historical event should take place in Texas," he added, "and that this DC-3 should end its service in Fort Worth where the DC-3 began service in 1936.

Fort Worth Still Flies.

"Although this DC-3 is leaving the fleet, I'm proud to say that the name of Fort Worth is still flying with the line." He pointed to the Convair.

"Hereafter Flagship Fort Worth will be this Convair."

The 16 passengers who came into Fort Worth from El Paso on the DC-3 posed for newspaper and television photographers, then watched as Miller made presentations to Amon Carter and William Holden, executive vice president of the Chamber of Commerce.

Carter was given a letter of greeting from R. F. Momsen, chairman of the El Paso Aviation Committee, and a leather plaque with the retiring DC-3's nameplate on it.

Then Carter hauled down the triangular blue pennant above the cockpit with a cord. He called it "a fine souvenir that I'll cherish."
Aided by the stewardess, Miss Margaret Van Bibber of 1006 W. Bowie, Carter sealed the old plane's door with adhesive tape.
