CEMETERY PRICES BRING OPS ACTION

SAN DIEGO, Cal., March 28 (AP).—This city was charged Friday with violating federal cemetery price ceiling. Treble damages of \$32,025 were demanded by the Office of Price Stabilization.

Patrick E. Gavin, OPS enforcement officer, said the amount was based on alleged overcharges for grave-stone bases, casket boxes, opening and closing graves and such items at Mount Hope Municipal Cemetery for a six-month period.

Mayor John Butler said prices had been raised because the city was losing money.

Fuel Facilities at Airport Impress Oil Men on Tour
