Petty Says Min But Can't Reca

Ted S. Petty, accused wife slayer, was a man with a clear present and a clouded past Tuesday.

"I can think all right now," the 38-year-old former North Side tavern owner said in county jail, where he is awaiting an April 10 sanity trial.

But Petty, who was returned here Monday from Terrell State

Hospital, said he couldn't remember shooting his wife to death here on Aug. 29, 1950. He said it was nearly three

months ago that he realized his mate, Mrs. Ruby Maud Petty, was dead,

Doesn't Know Why It Happened. "My folks told me about it."

he said. "I just don't know why that thing ever happened." "I've died a thousand times over the thing. I wouldn't have harmed a hair of her head if I had been in my right mind."

He also said he had no recollection of a hearing a month

after the shooting in which he was adjudged insane.

Petty's statements gave the key his courtroom defense.

Although he will not contest having his sanity legally restored at the forthcoming hearing, he will plead he was insane at time of the slaying when he faces trial for murder.

Insanity Defense.

The jury that ruled on his sanity after the slaying said he was sane at time of the shooting but insane at time of the hearing. But his attorney, Clifford Mays

said he will contend again that Petty was of unsound mind when he shot Mrs, Petty to death on a downtown street here.

Physically, Petty appeared to be a new man.
