TOBACCO MAILING INSTRUCTIONS

The German Government does not permit tobacco or tobacco products to be included in next of kin parcels to United States prisoners of war or civilian internees. However, a special committee made up of representatives of the War, Navy, and State Departments, Foreign Economic Administration, Post Office Department, Office of Censorship, and the American Red Cross has made arrangements with the tobacco companies listed below, whereby tobacco products may be forwarded, postage free, by these companies directly to the United States prisoner of war or civilian internee whose name is imprinted on the enclosed W. D., P. M. G. Form No. 26 and order, Form No. 26A.

In using the two tobacco labels, Form No. 26, be sure to detach them at the perforation from Form No. 19 which is the parcel label, the use of which is described in "Parcel Mailing Instructions."

Each tobacco label, Form No. 26, will permit the sending of *two units* as shown below, and must be forwarded to the tobacco company selected, accompanied by one properly filled out order, Form No. 26A (enclosed), with money order in the amount of the total purchase payable to the company selected.

A *unit* consists of 3 cartons cigarettes, or 100 cigars, or 24 ounces chewing or smoking tobacco, unless otherwise stated. Each label, Form No. 26, and order, Form No. 26A, may be used for either one or two units in ordering. You may order 3 or 6 cartons of cigarettes or the equivalent in other kinds of tobacco for each of the labels, Form No. 26, and orders, Form No. 26A, for one type of tobacco only.

DO NOT fill in your name and address under the word "Sender" on Form No. 26 as this space is for use by the company you select. Fill in order, Form No. 26A, only, and attach thereto label, Form No. 26, with your money order remittance and mail to the tobacco company. The prices quoted below are made possible by the exclusion of internal revenue taxes and represent the cost price to the tobacco companies on the items listed.
