by President Roosevelt to visit  
the protestant Chaplains in  
Africa & other American camps.

He is a personal friend of  
ours & will stay with us over-  
night next Sat Apr 10<sup>th</sup>  
when he comes to Miami  
to take a plane on his  
journey. When in Africa he  
is going to inquire through  
the Chaplain of Phil's regi-  
ment to see if any of  
Phil's comrades know whether  
or not that Phil was taken  
prisoner. If you will send  
me details as to your sons  
regiment I will ask the Bishop  
to make similar inquiries  
regarding your son

It will be some satisfaction  
to us if we know definitely  
that Phil is a prisoner.

Please send the information by  
return air mail or night letter  
so that I will have it Saturday  
when the Bishop stops with  
us. also please return this  
clipping regarding the Bishop

We will be leaving Florida  
for Buffalo about Apr 15<sup>th</sup>  
so I am enclosing a  
card with my Buffalo address  
in case you should want to  
write me after April 15<sup>th</sup>

I am not used to writing  
with a pen hope you can  
read it & hoping that we  
will soon get some definite  
news
