When you have received the package, I will appreciate your signing one copy of the inclosed receipt, indicating that you will act in the capacity stated, and returning it to this Bureau.


As previously stated, the forwarding of property by this Bureau does not, of itself, vest title in you. It is forwarded merely in order that you may safely keep it until the return of the owner.
