At the meeting of the Cabinet on Thursday the Library Committee made a report suggesting a library policy for the next five years. After a discussion the cabinet approved this report and the policy which it embodied and requested that it be distributed to all the members of the faculty.

Library Policies

The Library Committee suggests that T. C. U. pursue the following policy with regard to the acquisition of books during 1931-32, and if it proves satisfactory, during the five year period that follows.

- 1. Put emphasis on acquiring fundamental and basic texts, reference works, and scholarly publications. Tested, standard source materials for liberal arts courses should be secured before an attempt is made to keep up with the large output of recent volumes. Departments are urged to concentrate upon the basic tools in their fields when they request books to be ordered from their respective library budgets.
- 2. The general fund shall be devoted (1) to general reference works, and (2) to current books for leisure reading of the better sort.
- 3. The library fines fund shall be devoted (1) to replacement or repair of lost or worn-out books and periodicals.

for which there is a continued need in our library, and (2) to the purchase of back files of magazines and of rare or expensive sets that are beyond the resources of particular department funds.

The Library Committee will be glad to receive from Department Heads lists of desired data in their respective fields to be considered for purchase on the library fines account. The requests should cover, in prospect, purchases to be made during the next five years. The Committee will endeavor to apportion the expenditures equitable among the various departments.
