- l. Any case of dishonesty may usually be handled by a teacher, but in a case which he deems grave enough to be penalized, his findings must be reported to the Committee and approved before becoming final.
- 2. All cases of dishonesty in tests, examinations, or preparation of work will be dealt with in accord with the following principles: (1) in all ordinary cases the one convicted shall forfeit credit for the course; (2) in aggravated or repeated cases, the consequences may be suspension from the university.
- 3. That the name "Committee on Honor" be changed to "Committee on Academic Honesty".
