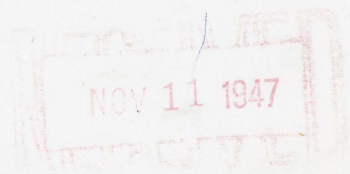
The tickets that were placed in our schools and institutions by your generosity meant the giving of much pleasure to many who have few such experiences and I am sure you will hear from many of these personally.
