# STUDENT CENTER WEEK, HOMECOMING, BOARD MEETING--NEXT WEEK!

A full week of activities are ahead as the University observes the formal opening of the remodeled and expanded Brown-Lupton Student Center, prepares for annual Homecoming events and welcomes the Board of Trustees to the campus for their fall meeting.

November 5 through 12 has been designated as Student Center Week and many, many events are scheduled to call attention to the importance of the Center's varied programs in the life of the University community: receptions, meetings, parties and games, coffees, films, dinners, special programs, Student Center tours—the list is long indeed. Posters and programs giving a day-by-day play of events will be available around the campus. Be sure to keep informed about what's planned for you'll want to attend many of the activities.

Of special importance is a luncheon, Fri., Nov. 10, highlighting the Week. Special tribute will be paid to the Brown-Lupton Foundation and the late Mr. Glenn Woodson, managing director of the Foundation, and to Dr. Thomas T. Richardson, dean of students at TCU from 1949-1956. The luncheon will be attended by TCU Century Club members, members of the Board of Trustees and their wives, administrative officials, student leaders and other invited guests.

Homecoming, which is being included in the special week, begins officially on Thursday night, Nov. 9, with a 7:30 p.m. pep rally at the Coliseum. The homecoming show, Friday, Nov. 10, will present trumpet showman Al Hirt. Tickets to the show are available in the Student Center for \$2.50, \$3 and \$3.50 each.

The University's Board of Trustees will meet Friday morning, Nov. 10, for their bi-annual meeting. That afternoon, a reception honoring TCU faculty members who have had books published within the last two years will be held in the Student Center lounge.

## 'BUSINESS WEEK' AT MID POINT

"Business Week 1967," sponsored by TCU's Delta Upsilon chapter of the international fraternity of Delta Sigma Pi, reached its mid-way point with this morning's (Nov. 1) discussion of "Business in the '70's" by F.W. Laughbaum, manager of the J.C. Penney store in Seminary South. Designed to focus attention on the cooperative aspects of business and education by bringing business leaders to campus for the entire Fort Worth community to hear and meet, this year's program began at 9 a.m. Monday when Charles Tandy, chairman of the Tandy Corporation, spoke on "Acquisition and Merger." Tuesday morning's guest was Glenn B. Coats, senior vice president of the First National Bank and also a TCU alumnus, who centered his address on "Banker, Bank and Banking."

Open to the public, tomorrow's session at 8 a.m. in Dan Rogers Auditorium will feature J. Lee Johnson III, executive vice president and general manager of Carter Publications, Inc. Named Fort Worth's "Salesman of the Year" in 1965, he will discuss "Business Is the Happening." Speaking at the final session, set for 11 a.m. Friday, will be Edwin T. Mahood, manager of commercial domestic sales of Bell Helicopter. His topic will be "The Helicopter in Your Future."

Chancellor J.M. Moudy will be the speaker at Thursday night's banquet for guest participants and students. To begin at 6:30 p.m. in Weatherly Hall, the event will be "m.c.'ed" by Dean Ike H. Harrison. Faculty members and Fort Worth's Mayor DeWitt McKinley, who officially proclaimed this as "Business Week 1967," will be among the guests.

## FORMER ASST. SEC'Y OF STATE TO SPEAK

Roger Hilsman, former assistant secretary of state for Far Eastern affairs, will speak on "The Crisis in American Foreign Policy" in the Student Center ballroom on Nov. 2. The lecture, sponsored by the Forums Committee, will begin at 8 p.m.

One of the country's leading authorities on foreign affairs and international politics, Hilsman served in the administrations of both John F. Kennedy and President Lyndon B. Johnson. Bringing together a wide range of experience into an authoritative point of view, he has been a professional soldier, a government administrator, intelligence expert, scholar, diplomat and now is a government professor at Columbia University.

Immediately following the lecture, Hilsman will be guest of students and faculty for an informal coffee in the main lounge of the Student Center.

#### GUEST PIANO RECITAL PLANNED

An event of Nov. 6 will be a guest recital by Pianist George Katz, teacher-performer at Ohio University, beginning at 8:15 p.m. in Ed Landreth Auditorium. His performance, part of the 1967-68 Guest Recital Series of the School of Fine Arts, will include works of Schubert, Skryabin, Schoenberg and Chopin. No admission will be charged.

While on leave from his academic post at Ohio in 1966-67, the artist presented debut recitals in London, Munich, Amsterdam and The Hague and appeared as soloist in concert and radio engagements in England, Holland, Germany, France, Italy and Bulgaria. Acclaimed by both press and public, he will return to Europe for another tour of concerts next spring. Katz, whose recitals include one in Carnegie Hall and two in Town Hall as well as an NBC-TV concert on the "Recital Hall" program, studied at Juilliard School of Music and in Paris on a Fulbright grant. In 1957 he became the first American to win a prize at the Concours Marguerite Long in Paris.

# CANADIAN SCIENTIST TO PRESENT LECTURE SERIES

Dr. J.R. Beerbower of McMaster University in Hamilton, Ontario, will present a series of two-hour lectures to begin at 4:30 p.m. daily on Nov. 6-10 in Winton-Scott Hall. A prominent Canadian scientist, Dr. Beerbower will lecture on paleoecology. He has written a widely-used textbook on paleontology and has published research on evolutionary theory, the origin of cyclothems and the environment of ancient terrestrial vertebrates and marine invertebrates.
