

Farley Is Honored Here on His 49th Birthday

Postmaster General Farley observed his forty-ninth birthday Sunday in Fort Worth.

When he departed at 5 p. m. for Baton Rouge, La., the Postmaster General carried with him the congratulations of many Fort Worth people, a sheaf of telegrams sent to him here from many parts of the Nation and a big birthday cake prepared for him here.

Farley was born at Grassy Point, N. Y., May 30, 1888, the son of James and Ellen Farley. His early schooling was at Stony Point. Afterward he attended Packard Commercial School, New York City; University of the South (D. C. L.), Seawane, Tenn.; Casinius College (LL. D.) Buffalo, N. Y.; Manhattan College, New York, John Marshall College, Jersey City, and Niagara University.

Began as Bookkeeper.

He married Elizabeth A. Finnegan of Haverstraw, N. Y., April 28, 1920. Their children are Elizabeth, Ann and James A. Farley Jr. Farley began his career as a bookkeeper for a paper company in New York City and later was sales manager for a gypsum concern there. He organized James A. Farley & Company in 1926, merged with five other firms in 1929 to form General Building Supply Corporation of which he was president until March 4, 1933, when he was appointed Postmaster General. He formerly was a member and chairman of the New York State Athletic Commission. Active in politics for many years, he became a national fig-

HOUSE SPEEDS RACE REPEALER

AUSTIN, May 31.—Fight of House antirace horse repeal members to delay consideration of the repeal bill kept the House in an uproar all morning but the repeal majority appeared determined to push the Bradbury bill through to final passage this afternoon.

If passed, the bill goes to the Senate where, so far, the antis have so manipulated their minority as to remain in complete control.

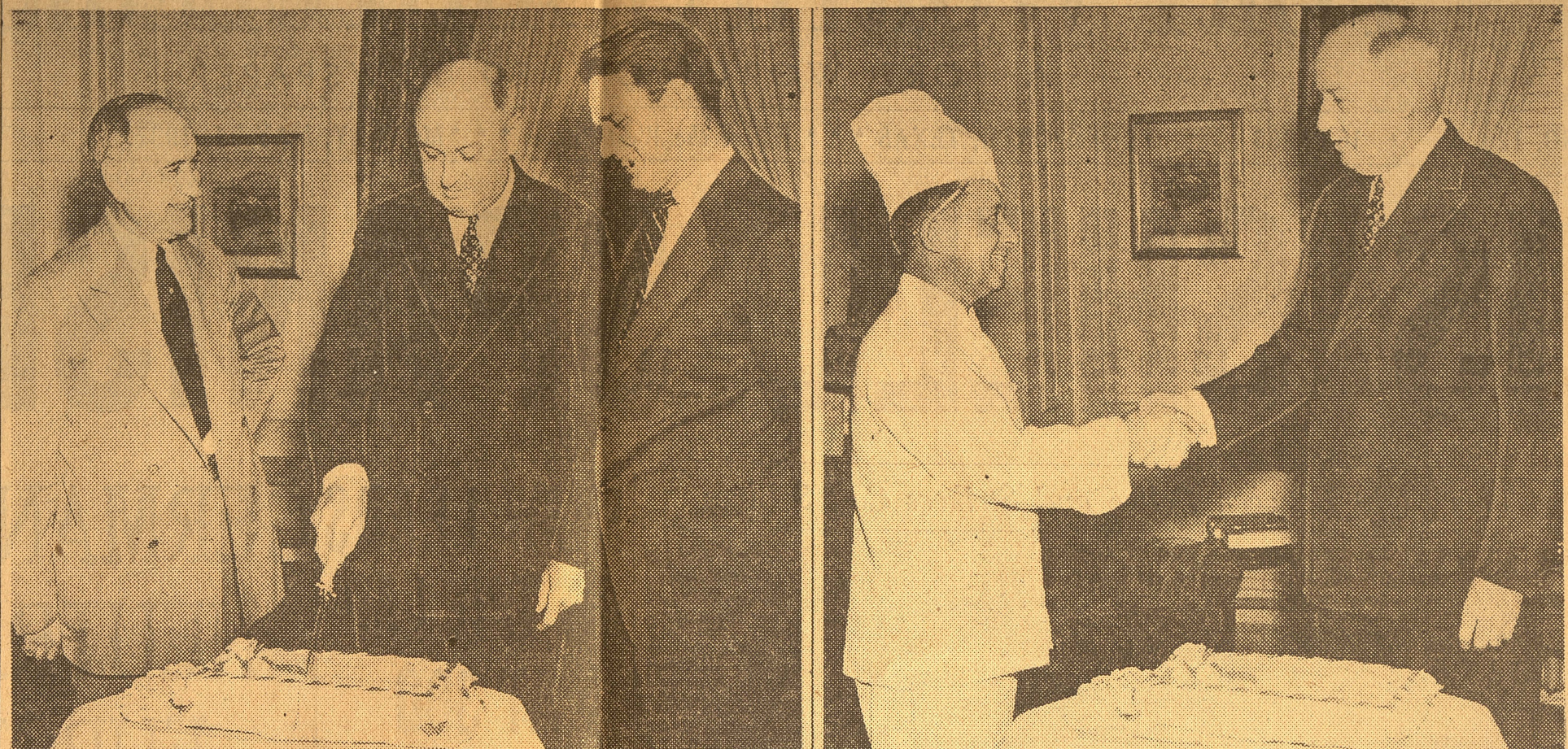
At the noon recess, a point of order against the entire Bradbury bill, as being outside the Governor's call, was under consideration.

In demanding immediate consideration of the Bradbury bill, the preponderant House majority:

1. Refused to hold Memorial Day services.
2. Refused to extend the time for considering resolutions.
3. Voted 92 to 36 to suspend all rules and take up the bill.

Officers attempted to stop the onrush by wielding clubs and fire tear gas guns. When the mob pushed on, determined to reach the main gate of the plant were 1,400 loyal workers kept the mill in operation, the policemen opened fire.

Meanwhile the Steel Workers Organizing Committee, an affiliate of John L. Lewis' CIO, planned a mass meeting and demonstration at Indiana Harbor where the Inland Steel plant has been idle since the strike was called over collective bargaining contracts. The mass meeting was to be attended by workers in the plants of three big independent companies—Inland, Republic and Youngstown Sheet and Tube.

Approximately 73,000 workers affected by the steel strike here and in four other States started their fifth day of idleness Monday.

At the Republic's plants in Warren and Niles, Ohio, the "strike or starve" blockade was tightened. Republic spokesmen claimed one of their loyal workers, waiting for food to be dropped from a corporation plane, was shot in the leg by strikers shooting at the craft.

Try to Beat Blockade.
In an effort to beat the blockade, Republic officials at Buffalo arranged to move a field kitchen and Pullman sleeping cars into the plant for loyal workers.

Meanwhile, President William Green of the American Federation of Labor announced at Cincinnati that the executive council after a week-long conference agreed on the expulsion of Lewis' rebel unions, and sought approval of central bodies in the doubling of assessments to provide approximately \$30,000 a month for the federation's "war chest."

At Detroit, F. J. Dillon, AFL official, asserted that Ford workers had asked him to help them in opposing the UAWA, an affiliate of Lewis' organization. It marked the first step in the battle between the two groups for members among employees of the Ford Motor Company and other producers.

John Brophy, CIO director, announced at Washington that Lewis' union soon would move into every industry which has no labor organization or where existing unions "are not taking care of their members."

R. H. HUNTER FUNERAL HELD AT GAINESVILLE

Services were held in Gainesville Sunday afternoon for Robert Horace Hunter, 65, retired automobile dealer, who died of a heart attack Saturday at his home, 950 Fifth Avenue. The funeral was conducted at the Harveson & Cole Chapel. Mr. Hunter is survived by his widow; a daughter, Mrs. Ruth Oliphant; a sister, Mrs. C. C. Braggans, and a grandchild, all of Fort Worth.

SPANIARD SUNK BY ITALIAN SUB

BARCELONA, Spain, May 31 (AP).—Catalan government officials announced Monday they had confirmed that an Italian submarine launched the torpedo that sank the Spanish passenger liner Ciudad de Barcelona. They declared 50 passengers were drowned and several others were injured when the ship was sent to the bottom of the Mediterranean Sunday.

An official announcement said: "Yesterday morning a submarine which was unmistakably of Italian nationality attacked a Spanish merchant ship in Spanish waters without any warning."

"The merchant ship continued its route without being touched by torpedoes. One of these torpedoes went aground on Calella beach where technical experts, after an examination, confirmed it was of Italian manufacture."

"At 3 p. m. the same day the submarine, still in Spanish waters near Malgrat, attacked the motorship Ciudad de Barcelona, which sank in less than an hour. Fifty passengers were drowned, several others injured."

Bernard Titche Sr., New Orleans, Dies

NEW ORLEANS, May 31 (AP).—Bernard Titche Sr., 78, an attorney here for more than 50 years, died Sunday. He had been intermittently ill a year.

Surviving him are his widow; a son, Bernard Titche Jr., with whom he had been associated in legal practice, and a brother, Edward Titche, Dallas, Texas. The funeral will be held today.

Titche was born in Winnsboro, La., and lived there until his family moved to New Orleans in 1870. Graduated from Yale University in 1882, he was admitted to law practice in this State two years later after studying here in the offices of Gibson & Hall. The latter was then United States Senator from Louisiana.

For some years Titche was a member of the firm of Titche & Rogers, in association with Justice Wynne Rogers, now of the Louisiana Supreme Court. He had been for several years a member of the advisory board of Yale University and was a member of the Louisiana Historical Society, the New Orleans Chess, Checker and Whist Club and the Free and Accepted Masons.

Hearty Welcome Extended.

The Postmaster General arrived here Sunday at 2:40 p. m. from El Paso, stopping off for a brief rest between trains as the guest of Amon Carter at the Fort Worth Club. A hearty welcome was extended Farley by a crowd which had gathered at the Texas and Pacific Passenger Terminal and later the birthday cake was presented.

Flashing the famous Farley smile as he put on a linen duster, the postal chief appeared to enjoy the reception as he was escorted to a 1902 model Cadillac automobile for a ride to the Fort Worth Club. Riding with Farley in the oldtime vehicle were Elliott Roosevelt, United States Marshal Wright, Amon Carter and Roy Blackwell, the driver. They also sported linen dusters. The car belongs to Carter.

With Farley on Trip.

Accompanying the Postmaster General on the trip are Smith W. Purdum, Fourth Assistant Postmaster General, and their secretaries. Among those on hand to greet Farley were Postmaster Henry Young and members of his staff, Mayor Hammond and City Councilmen Elder, Rumph, Eagle, Hull, Seaman and Martin; Milburn McCarty, Eastland, president of the West Texas Chamber of Commerce; Raymond E. Buck, Federal Judge Davidson, Walter B. Scott, Joe T. Steadham, W. P. McLean Sr., W. P. McLean Jr. and Dr. Hodges McKnight. On the train which brought the Postmaster General here were Karl A. Crowley, solicitor of the Postoffice Department, who had joined Farley at El Paso; United States Attorney Eastus and Marshal Wright, who boarded the train at Weatherford, and Postmaster R. K. Phillips of Weatherford.

After a bath and shave at the Fort Worth Club, Farley was taken to a room where the birthday cake had been placed. It was decorated to represent an airmail letter, even to an icing stamp. There was a red, white and blue border and the inscription, "Hon. James A. Farley, Happy Birthday."

Compliments Chefs.

Farley complimented the chefs, J. E. Wurth and Charles Shotta, as he took over the job of cutting the cake. He asked that the remainder of the cake be placed on the train. After the cake-cutting the Postmas-

ter General was presented with a new hat by Carter. Farley was wearing the hat when he left.

During his informal stay in Fort Worth, Farley discussed various things, praised Fort Worth's federal structures, the postoffice building and United States Courthouse, and congratulated Roosevelt on his election as a member of the Texas A. & M. College board.

In response to questions about the Administration, Farley said:

"In my opinion, whatever program President Roosevelt has will be carried to completion by the present Congress. Now when you ask about the Supreme Court, I'll repeat the same assertion, and tell you to draw your own conclusions."

Fort Worth Still Best.

Boarding the train, Farley stood on the rear platform and waved farewell, remarking as the train pulled out, "Well, Amon, I still think Fort Worth is the best city in Texas."

While here Purdum held a conference with Postmaster Young and James Rowland, first assistant to the postmaster. Secretaries on the trip with the postal officials were William J. Bray, secretary to Farley, and Al Horton, aid to Purdum.

The Postmaster General's schedule for the remainder of his trip includes a commencement address tonight at Louisiana State University in Baton Rouge, dedication Tuesday of a new federal building at Vicksburg, Miss., dedication of another new building Tuesday night at Magnolia, Ark., and the inspection of 15 postoffices on a motor trip through Arkansas Tuesday. He will address a meeting of Arkansas postmasters Wednesday afternoon at Little Rock and speak to postal clerks Wednesday night at Memphis. A federal building will be dedicated Thursday at Hodgenville, Ky. Farley is due back in Washington Friday.

REV. JEFF D. RAY HEARD AT AZLE CELEBRATION

this bill because they knew he was popular, as smart as greased lightning, as sweet as an old woman and as pure as an unused girl. They knew he would protect the bookies. If you're as pure as you say you are, Bryan, why not put the bookies into this bill?"

Pope, keeping the House shouting with laughter for nearly an hour, threw his charges recklessly. He referred to the "Allred-subsidized press here in front of me," waving at the press table, and declared that "Jimmy and his army hasn't been able to put the bookies out of business." He made frequent references to a "former Attorney General" as the guiding spirit of the bookies and inferred "protecting the bookies" was the reason the call for the session did not embrace that subject.

"What's wrong with putting out the bookies?" he shouted. "What's wrong with that, Mother Bradbury?"

He charged that under Bradbury's bill, all that would be necessary to keep on betting would be to tear down the enclosures around tracks.

"The reason they talk about the Legislature and call us fools and jackasses is because of the things we let folks do to us. They made Bryan (Bradbury) believe you can raise mules without a jackass."

Representative Leonard of McAllen wanted to print Pope's lecture on the "facts of life" in the journal. Then Bradbury replied:

"I was advised by no man on introducing this bill at the regular session; but I will tell you that I would rather receive advice from James V. Allred than be dictated to by Archie Parr and the Mexican army." Parr, former State Senator from Pope's district, is acknowledged power in politics in the section. "I'm glad I don't have to run to a telephone or telegraph and get in touch with Archie Parr before I make a speech."

"Why Elmer Pope, the man who got 2,000 votes out of 750,000 in a race for Governor, his views of what is right are so warped that he couldn't tell the difference between a knothole in a piney fence and the pearly gates of Heaven."
